Governor Signs Government Omnibus Act of 2009

On October 11, the governor signed Senate Bill 113, the Local Government Omnibus Act of 2009, containing nineteen amendments to California's county law library statutes. The amendment update and modernize various law library codes related to finance, governance, and operations in the Business & Professions Code, and will go into effect January 1, 2010 (Stats. 2009, Ch. 332, Sec 1.1 - 1.18).

Due to a rigorous vetting process before the amendments were added to the bill, no issues were encountered with the library provisions, and S.B. 113 progressed through both houses on their consent calendars. The bill was enrolled and, on the last day, the governor signed the Omnibus Bill.

CCCLL is deeply grateful to the Legislature for its support in improving the state of county law libraries in California. Our law libraries are excited to serve and provide the legal information services supporting access to justice for all Californians.
